This licence is governed by the terms set out as follows, which may not be altered in any particular without written consent from the Gallery.

Licence terms for the Electronic use of Images (off-line)
--

The National Gallery of Ireland (“the Gallery”) agrees to grant a non-exclusive licence in the territory specified overleaf to the person or company named overleaf (“the Licencee”):

- (a) to record and hold the photographic images described overleaf (“the Images”) on an electronic database under the Licencee’s control;
- (b) to reproduce the Images once on the electronic product described overleaf (“the Product”); and
- (c) to reproduce no more than one image for the purposes of advertising the Product on the web-site specified overleaf

until expiry of the Term or until the production run specified overleaf is completed, whichever occurs soonest.

2. This licence is granted subject to the following conditions:

- (a) no re-use or further reproduction of the Images whether for future production runs or otherwise is permitted except on payment in advance of additional fees;
- (b) no copy of the Images shall be of any greater resolution than 240 pixels wide or 240 pixels high;
- (c) the Licencee may not copy any version of the Images other than the transparencies or other versions delivered by the Gallery for the purpose. Any such original transparencies or other versions of the Images shall be returned to the Gallery no later than 5 working days after they have been recorded by the Licencee pursuant to 1 (a) above. The Licencee shall be fully liable for any loss or damage to such transparencies or versions while they are in the Licencee’s possession or control;
- (d) the Licencee shall encrypt the digitised Images using an agreed encryption code or watermark unique to the Product which is traceable in all copies;
- (e) the Licencee hereby assigns any copyright and similar rights throughout the world in any digitisation of the Images created by or for the Licencee for the full term of such copyright and similar rights including extensions and renewals;
- (f) the Licencee warrants that it has or shall have obtained all necessary permissions from the owner of any copyright in the work recorded in the Image and indemnifies the Gallery against all costs, damages and expenses which the Gallery may incur as a result of failure to obtain such permissions;
- (g) all copies of the Product and its packaging and any accessible displays of the Images on screen shall be accompanied by (i) a copyright notice prohibiting any

- form of reproduction, transmission, performance, display, rental, lending or storage in any retrieval system without the consent of the copyright holders; and (ii) a credit acknowledging that the Images have been used with the permission of the Gallery, such credit to be of a size and in a place to be agreed; and (iii) a credit in a form to be agreed identifying the author of the Images;
- (h) at least two copies of the Product shall be given to the Gallery free of charge following publication;
 - (i) on completion of the production run specified overleaf, all copies or records of the Images made under this licence shall be erased from the Licencee's database and a certificate provided to the Gallery to that effect, unless a further production run is agreed and the relevant additional fees paid;
 - (j) no adaptation, alteration or manipulation whatsoever of any of the Images is permitted without the prior written consent of the Gallery;
 - (k) the licence may not be assigned, transferred or sub-licensed without the prior written consent of the Gallery;
 - (l) the Licencee shall ensure that third parties including distributors are bound by the terms of this licence; and
 - (m) the Licencee shall inform the Gallery of any unauthorised use in any of the Images as soon as it becomes aware of the same.
3. In consideration of this licence, the Licencee shall pay the Gallery the licence fee and the royalties set out overleaf. The licence fee and royalties apply to this licence only. The said sums are exclusive of VAT which shall be payable in addition at the rate and in the manner prescribed by law. The licence fee shall be payable prior to delivery of the Images to the Licencee. Where royalties are due, the Licencee shall within 30 days of each quarter day provide and account of the amount due in respect of the quarter ending on that quarter day and shall pay the said amount within 30 days of the Gallery's invoice therefor. The licence fee and royalties do not include print fees and hire charges, which may be invoiced by the Gallery in addition.
4. This licence may be revoked at any time if the Licencee is in breach of any of its terms.
5. This licence shall be governed by the laws of Ireland, whose courts shall have jurisdiction in the event of any disputes.
